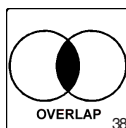
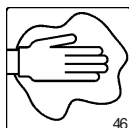


# TECHNICAL INFORMATION SHEET CARPET CLEANER

## INTRODUCTION

The Premiere range of ozone friendly aerosol products designed to meet most housekeeping needs in hotels, halls of residence, nursing homes and other residential premises. These products are also suitable for use in commercial premises for the routine care and maintenance of furniture, washable hard surfaces, internal glazing (including mirrors) and fixtures and fittings in offices, classrooms and shops etc.

A spot and stain remover for carpets and fabrics.

## DIRECTIONS

Always wear the appropriate protective clothing and read product label and material safety data sheet before use.

## APPLICATION

Vacuum carpet. Shake well. Turn can upside down and test spray small area for colour fastness. Spray a thin layer of foam from 60 cm (2ft) over the stain still using the can upside down. Once foam has dispersed, agitate with cloth or soft brush working from the outside in. Repeat if necessary. When carpet is dry, vacuum thoroughly.

**Avoid** any inhalation of airborne mist when using aerosol spray products.
