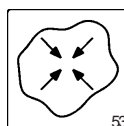
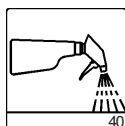
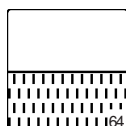

INTRODUCTION

The Premiere range of high quality carpet care products has been formulated for the periodic deep cleaning and routine treatment of all types of carpet, rugs and upholstery.

The use of the appropriate carpet care product and equipment will remove dirt, grit and dust, enhancing the appearance and considerably extending the life of all textile surfaces and fibres.

First class results can only be achieved using the correct products, machines and equipment within the framework of a regular cleaning programme. This range makes it possible to select a carpet care product with precisely the right characteristics for the task and equipment available.

CARPET MOUSSE

To compliment the full range of carpet cleaning products, **Carpet Mousse** is a high performance carpet spot and stain remover. **Carpet Mousse** will remove typical dirt, debris or staining from all common carpet types (may also be used on heavy fabrics and upholstery). **Carpet Mousse** has been awarded the Woolsafe Mark of Approval.

A water based trigger spray product based upon the latest Dri-Foam technology. **Carpet Mousse** contains high performance wetting agents to allow rapid infusion into soil to maximise stain removal, as well as being polymer based to eliminate any potential for rapid re-soiling. To minimise wet wool malodours, **Carpet Mousse** also contains a fresh aqua perfume.

Carpet Mousse has a neutral pH, containing readily biodegradable surfactants and polymers that biodegrade to DIN 38412/25 more than 90%. **Carpet Mousse** is also very safe in use as it does not require an orange box hazard warning symbol to be displayed or contain any EH40 - C.O.S.H.H. regulated components.

Carpet Mousse is free from phosphates, optical brighteners and oxidising or reducing agents.

DIRECTIONS

Always wear appropriate protective clothing and read product label and material safety data sheet before use.

It is important to test all textile surfaces for colour fastness before carrying out any cleaning procedure. Always check that the chosen cleaning technique is compatible with the type of carpet to be cleaned.

1. CLEANING TECHNIQUES BY HAND

1.1 Stain Removal - Firstly undertake a colour fastness test. Remove or scrape away any solid matter. Spray **Carpet Mousse** directly onto stain and allow 2-3 minutes contact time, then agitate with a damp sponge or cloth. On hard wearing surfaces, or for stubborn marks, a soft hand brush may be tried. During agitation always brush into the centre of the mark to reduce the size of the stain and avoid spreading it. If necessary, repeat application then when the task is completed and the area has dried, vacuum thoroughly.

TRAINING ACADEMY

The Technical Staff in the Training Academy can ensure that the correct equipment and methods are used and our consultants can provide on-site training and advice. Standard two day training courses are held regularly in Cheltenham, and tailor-made courses can be arranged if necessary.
